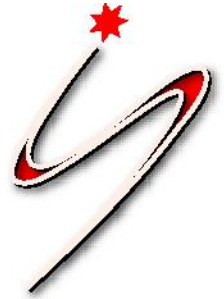
**VENDOR SPACES**
